

D-dimer (or **D dimer**) is a fibrin degradation product (or FDP), a small protein fragment present in the blood after a blood clot is degraded by fibrinolysis. It is so named because it contains two D fragments of the fibrin protein joined by a cross-link.^[1]

D-dimer concentration may be determined by a blood test to help diagnose thrombosis.^[2] Since its introduction in the 1990s, it has become an important test performed in people with suspected thrombotic disorders, such as venous thromboembolism.^{[2][3]} While a negative result practically rules out thrombosis, a positive result can indicate thrombosis, but does not exclude other potential causes.^[3] Its main use, therefore, is to exclude thromboembolic disease where the probability is low.^{[1][2]}

D-dimer levels are used as a predictive biomarker for the blood disorder, disseminated intravascular coagulation and in the coagulation disorders associated with COVID-19 infection.^{[1][3]} A four-fold increase in the protein is an indicator of poor prognosis in people hospitalized with COVID-19.^{[1][3][4]}

Transparency advocates have criticised the US Food and Drug Administration's (FDA) decision not to hold a forma advisory committee meeting to discuss Pfizer's application for full approval of its covid-19 vaccine.

Last year the FDA said it was "committed to use an advisory committee composed of independent experts to ensure deliberations about authorisation or licensure are transparent for the public." But in a statement, the FDA told *The BMJ* that it did not believe a meeting was necessary ahead of the expected granting of full approval.

"The FDA has held numerous meetings of its Vaccines and Related Biological Products Advisory Committee (VRBPAC) related to covid-19 vaccines, including a 22 October 2020² meeting to discuss, in general, the
